PAYMENT OPTIONS

Tuition and social education fees, along with any additional optional fees, are added together. This total is what is owed for the 2024 - 2025 school year. A \$250 enrollment deposit is required at the time of enrollment. This deposit is deducted from tuition and is processed approximately 10 days from the day the enrollment packet is submitted.

Families have the following options for 2024 - 2025 school year payments:

- Payment in full - due *no later than* May 1, 2024
- 12 monthly payments - due on the first of the month; Monthly payments will begin June 1, 2024, continuing through May 1, 2025.

FACTS TUITION MANAGEMENT

Crescent Ridge Academy partners with FACTS Tuition Management to manage our fee collection process. Participation is required. There is an annual \$55 set-up fee for the 12 monthly payment plan and a \$25 annual set-up fee for the payment in full plan. Families choose their payment plan and provide a payment method within the online enrollment process. After enrollment, families can access personal FACTS accounts through the Financial section of the Family Portal.

DISCOUNTS (APPLIED TO TUITION FEES ONLY)

- Paid In Full discount of 5%. Must be made by May 1, 2024, no exceptions, with a deposit of \$250 required at the time of enrollment.
- Sibling Discount: 2 siblings, 5% off youngest child
 3 siblings, 10% off youngest child
 4 siblings, 15% off youngest child
- Discounts may be combined

FINANCIAL AID

Limited financial aid is available. Financial aid applications are processed through FACTS. In order to be considered for financial aid, applications along with all required tax forms must be submitted no later than January 15, 2024. A link to the financial aid application can be found on the front page of CRA's online application (new families) or in the Financial section of the Family Portal (current families).

Decisions regarding financial aid will be made by January 31, 2024 and all applicants will be informed of the decision by this date. Applicants are responsible for informing the Director of Admissions of their enrollment decision, and aid will be applied to payment plans accordingly.
